WHEREAS, The Board of Commissioners of the Erie County Water Authority has made a determination that qualified, senior staff personnel are essential to the mission of the Authority and to the continued success of serving the public good; and

WHEREAS, In order to maintain the continuity of professional management for the ECWA during a period of dynamic growth, it is desirable and appropriate to offer an employment contract, with a severance agreement contained therein, to the Executive Director; and

WHEREAS, Mark J. Fuzak, Attorney for the ECWA, has reviewed the employment contract, including the severance agreement, and has approved the same as to form;

NOW, THEREFORE, BE IT RESOLVED:

That the Chairman of the Erie County Water Authority is authorized to execute an employment contract, including a severance agreement, with the Executive Director.
