WHEREAS, Robert J. Lichtenthal, Jr., Deputy Director advises that it is in the best interest of the Authority to amend the Authority's current Guidelines to read as per attached Schedule "A"; and

WHEREAS, Robert J. Lichtenthal, Jr., Deputy Director and Robert A. Mendez, Executive Director recommend amending the Authority's Guidelines;

NOW, THEREFORE, BE IT RESOLVED:

That the Authority amend the Investment Guidelines as noted on attach Schedule "A".
