WHEREAS, Heretofore and on the 23rd day of April, 2009, the Erie County Water Authority ("Authority") entered into a contract with Gehring Pumps, Inc. for the furnishing of submersible agitator pump for Erie County Water Authority, identified as Contract No. 09-12-04; and

WHEREAS, Robert A. Niederpruem, Sr. Production Engineer advises that it is necessary to purchase a second agitator pump and is satisfied with the quality of the pump submitted by Gehring Pumps, Inc.; and

WHEREAS, Robert A. Niederpruem, Sr. Production Engineer, Wesley C. Dust, Executive Engineer and Paul H. Riester, Director of Administration recommend that the Authority waive its Purchasing Guidelines (Purchasing Guidelines Policies and Procedures Standard Monetary Guideline page 12) and acquire an additional unit, as specifications were awarded; and

WHEREAS, Robert A. Mendez, Executive Director concurs with said recommendation;

WHEREAS, Robert J. Lichtenthal, Jr., Deputy Director and Robert A. Mendez, Executive Director recommend accepting the above offer to extend coverage;
