

**ADDENDUM NO. 1 to  
PROFESSIONAL SERVICES CONTRACT**

ADDENDUM NO. I (“Addendum No.1”) to the PROFESSIONAL SERVICES CONTRACT (the “Contract”) made this \_\_\_\_ day of June, 2018, between the Erie County Water Authority (the “Authority”) and Clark Patterson Lee (the “Consultant”).

**RECITALS:**

WHEREAS, on May 31, 2018, identified on the Board Agenda as Item No. 5, the Authority’s Senior Distribution Engineer sought authorization from the Authority’s Board of Commissioners (the “Board”) to enter into a Contract for the design and construction of approximately 4,700 linear feet of new distribution waterline on Ledge Lane from Sheridan Drive to Greiner Road, approximately 500 linear feet of new distribution waterline on West Ledge Lane from Ledge Lane to the dead-end, and approximately 900 linear feet of new waterline on Clearview Drive from Ledge Lane to Galbraith Road in the Town of Clarence, with the existing waterlines to be abandoned in place;

WHEREAS, the Board tabled the item for purposes of seeking further clarification as to the payment of services for Resident Inspection services described in Section 2B4 of the Contract; and

WHEREAS, on June 14, 2018, the Board removed Item 5 from the Table and voted to approve the Contract, conditioned on this Addendum No. 1 being signed by both the Authority and the Consultant;

NOW, THEREFORE, in consideration of the mutual promises herein set forth, the parties agree as follows:

1. Pursuant to Section 3A4 of the Contract, the Authority agrees to pay the Consultant the direct cost of labor, times a multiplier based on the hours worked at straight time (without over time premium), in amount not to exceed \$87.50 per hour.
2. Pursuant to Section 3A4 of the Contract, the Authority agrees to pay any and all non-salary, direct expenses. Consultant will provide the Authority with receipts for any non-salary, direct expenses.
3. Pursuant to Section 3A4 of the Contract, the Consultant may bill the Authority monthly on the actual costs incurred in paragraphs 1 and 2 of this Addendum No. 1.

4. Pursuant to Section 3A4 of the Contract, the Authority further agrees to pay the Consultant an additional fixed fee of \$10,600.00, as set forth in Section 3D1 of the Contract. This fixed fee shall be billed separately from the costs incurred in paragraphs 1 and 2 of this Addendum No. 1. Payment for the fixed fee will be made monthly based on the proportion of the construction completed.

IN WITNESS WHERETO, the parties hereto have executed this Addendum No. 1 as of the date first above written.
