Install/Porting Process: 45 day interval

In preparation for these events your PBX/Key telephone vendor needs to be on-site as he/she will need to make connections into the TW Cable network box. TWC's Voice Coordinator will be in touch with your PBX vendor as they need to have the proper hardware/software in place for this service to work. The Voice Coordinator will provide your organization a Cut-Sheet prior to activation of the service for your review. The Cut Sheet includes technical details of the PRI Trunk and includes, list of DIDs, Clocking Source, Central Office Emulation, out pulse digits, Coding and Framing.

Testing and porting process - Your fiber connection will be delivered and is already 'lit' so all we need to do connect voice gateway equipment. This will arrive preloaded with all of your numbers and a test number. Our onsite technician will work with your PBX technician and make sure the PBX and TWC network are functioning properly prior to any number porting. In addition, off line calls will be made (both in and out) to authenticate validity of the PBX to our network. Our engineers and technicians will have visibility to these test calls and will be able to see success (or failure) of all test calls made.
