Claimant's Statement (please be specific):

On September 2nd at approximately 2:00AM the watermain under the end of my driveway at [redacted] burst. This break caused significant damage to the end of my driveway and caused a large amount of water and mud to enter my house through my garage door. Muddy water flowed from the garage into my basement causing flooding to occur in two rooms in the basement. Little to no damage occurred in the utility room except for minor issues. However in our weight room the rug was soaking wet with muddy water. If it was not for my daughter-in-law and her parents, it would have been worse, they pushed the water to the drain and moved things that could have been damaged out of the way. My wife and I were out of town and returned to a large cleanup. We had to remove the wet and moldy smelling carpet and spent a considerable amount of time spraying and washing the mud from the garage floor + basement floor that was left when the water main was repaired. We went to Home Depot and Custom Carpet Centers for quotes. Both said in order to receive a quote they would have to come to the house to measure and this would cost a fee that would come off the total if purchase was made. Both simply wrote down the carpet price for the amount I needed. I measured a 13 x 22 or 286 sq ft of carpet. I would install the carpet. Both quotes →
