#### A) SECRETARY

#### 1. Organizational Chart Updates

McCracken

Mr. McCracken distributed a revised and updated organizational chart for the Authority. He advised this is a work in progress. He discussed this with Mr. Stoll, Ms. Prendergast, Ms. Murphy and briefly with Mr. Lichtenthal. He requested input from the Commissioners.

Mr. Schad expressed his concern that the Authority needs to be compliant with the ABO requirement to post the Authority's organizational chart. Mr. Lichtenthal advised that the Authority does currently have an organizational chart in place, therefore the Authority is compliant.

Mr. Jones indicated his concerns as the Authority's enabling legislation only mentions two staff persons under the Board of Commissioners, the Attorney for the Authority and Engineer for the Authority. He feels the Executive Engineer should be on the same level as the Attorney.

Mr. Schad expressed his disagreement with this and referred to Mr. Lichtenthal for input. Mr. Lichtenthal stated the Authority's organizational chart in the past has clear lines of authority as to who reports to who and who has budgetary responsibilities and thus the obligation to get the job done. Mr. Jones disagrees and feels that since the Executive Engineer is appointed directly by the Board, as is the Attorney. Mr. Jones feels that somebody appointed directly by the Board should be reporting directly to the Board, especially since that position is specifically mentioned in the enabling legislation.

Mr. Carney questioned whether this has been reviewed with the new Executive Director. Mr. Carney stated that he has no objection to this chart but advised that this needs to be reviewed with the new Executive Director when he starts.

Mr. Schad would like this discussed with Mr. Mye and brought back to the Board at one of the February board meetings.

#### 1. Investment Report

Lichtenthal

Mr. Lichtenthal distributed and reviewed the December 2018 Investment Report. He advised that there was a decline in cash balance because as of December 1, 2018 as the 2008 bonds were finally paid off.

Mr. Jones brought up the end of March deadlines for the ABO filing and questioned the scheduling of meetings. Ms. Prendergast advised that Drescher and Malecki are on the agenda for the March 21, 2019 meeting. Mr. Jones advised he has a scheduling issue for the last week in March. Ms. Prendergast advised that the March 21<sup>st</sup> meeting will be the last meeting necessary. Mr. Lichtenthal advised that there might be some time constraints as Drescher & Malecki needs to have an exit conference with staff and have draft statements by the deadline at Noon on March 12, 2019 for the March 21, 2019 meeting. Mr. Carney requested the Board to review the upcoming meeting dates.

#### 2. Utilities Billing Audit

Lichtenthal

Mr. Lichtenthal distributed a memo regarding Troy and Banks, a company that researches municipalities utility bills to determine if they have overpaid. He advised that the company has had great success in recovering funds for clients in the public and private sector. Mr. Lichtenthal believes the Authority can piggyback off of a contract with Rockland County and not go through a bid or RFP process and with the Board's approval enter into an agreement to perform a utility audit. The company would receive payment only if it is successful in recovering any monies. Mr. Lichtenthal advised that Rockland County was successful with this company and requested that the Authority look into piggybacking off of Rockland County's contract. Mr. Carney expressed his concerns about the Authority making a decision based another county's decision versus using the RFP process. Mr. Schad asked Legal to research this matter and report back to the Board.

### 3. 2019-2020 Insurance Program Lichtenthal

Mr. Lichtenthal distributed a memo regarding ECWA insurance program. He advised that past practice when this was sent out as an RFP, it was sometime arduous and at times did not serve the Authority's best interests. The Authority went with hiring a broker to go to the marketplace on the Authority's behalf. He advised this was three years ago and the Board needs

to decide how to move forward at this time. Mr. Lichtenthal recommends extending the broker of record for another year. Mr. Carney and Mr. Schad advised to place this matter on the agenda for the next meeting.

Mr. Stoll distributed a proposed RFP for two projects coming up in the next year. The first is the design and construction for a raw water transmission main and the second is a routing study for delivered water transmission main. He gave an overview of the projects. Mr. Carney questioned if this is for two separate projects if there should be two separate RFPs. Mr. Stoll advised that they would be sent to the appropriate firms for the different projects. The Board advised to move forward and this will be on the next agenda for resolution.
