This incident caused water to flow (a considerable amount) many gallons in Laundry room that went under Floor Also into the Kitchen under the floor that connects into Laundry Room. The water also traveled beyond Laundry room walls into hallway soaking through the Carpet and baseboard. Water puddled into the bathroom which is connected by wall of Laundry room. No visible damage to tile floor in Bathroom just to baseboard soaking in water. I have had 2 estimates for the Claim for damage done by water to the Laundry Room & Kitchen Floor And Also the Carpet. I will not seek any damages to bathroom baseboard even though the damage will be in pictures. The gentlemen changed the meter and when done he realized he put the Meter on backwards. He then shut the water off and re-did the job without Incident. He was very Apologetic, The whole Time.
